Manage ESG Related Risk


Manage environmental and social related risks and implement governance to ensure the relevant controls and treatments are in place.

ESG Compliance



ESG Incident Management


Capture incidents, events and near misses related to ESG initiatives in real-time and manage cases through to resolution.

Online Registers & Workflows


Keep track of the ESG metrics you need by setting up online registers with integrated workflows to automate any spreadsheet-based process and bring it online.
